

**LOCAL 2252 SCHOLARSHIP FUND  
GENERAL  
2017**

This fund is for the benefit of any dependent children of Local 2252 active dues paying **member** who has been in good standing for at least one calendar year before date of drawing.

**Eligibility**

Any dependent child of a member of Local 2252 may be eligible for the scholarship if that member belonged to Local 2252 for at least one calendar year before the date of drawing. Applicants must be either a high school graduate or a student who will graduate during the year in which they apply.

**Scholarship**

Two scholarships for \$500.00 each will be awarded each year to a student who will be attending college as a freshman on a full-time basis (12 credit hours per semester or quarter). **Prior winners** of this scholarship will ***not*** be eligible for any further scholarships.

Two scholarships for \$500.00 each will be awarded each year to a student who will be attending college as a sophomore, junior or senior on a full-time basis (12 credit hours per semester or quarter). **Prior winners** of this scholarship will ***not*** be eligible for any further drawings.

**Deadline**

Applications will be accepted during the months of June through July, with July 31st of this year being the final date for accepting applications.

**Selections**

Winners will be chosen by lottery in August this year and each year thereafter until such times as the Governing Body of this Scholarship Fund determines that it will be terminated. A runner-up will be chosen for each scholarship; in the event the winner defaults.

**Funding**

The Local will budget \$2,000.00 a year to be used towards scholarships.

**Requirements of Winner**

The scholarship winner(s) may pursue whatever courses for college credit they wish at any accredited College or University with the exception of Correspondence courses.

**Governing Body**

CWA Local 2252 Executive Board will be the Governing Body and Administrators of this scholarship fund. The applicant(s) will agree to abide by all rules set forth by the governing body.

**Exceptions**

No member of the Governing Body or their immediate family shall be eligible to participate in the Scholarship Program.
